- 1. Call to order at 5:15 pm by Board President Tatro. Proper notice given in compliance with Wisconsin State Statute # 19.84. Roll call was taken.
- 2. **Resident Input** None.
- 3. March 26, 2025 Meeting Minutes Henry / Breunig motioned to approve March 26, 2025 Meeting Minutes as presented. Motion carried.
- 4. Parcel #243 N2455 Rapp Rd requesting variance on Ordinance Section 3.3 Owner's Maintenance of Building Sewer- Property owner Dave Buechner plans on developing parcel #243 in to two separate parcels. One by the lake and the other in front of lake property. This property was zoned as recreational when the sewer line was put in and the cottages on the property were allowed to share a private man hole with a "Y' lateral inside. Henry / Breunig motioned to allow the requested variance to Ordinance Chapter 3 Section 3 "Owners Maintenance of Building Sewer" with the provisions as follows: the Okee Sanitary District requires a Deed Restriction added to both Lot #1 and Lot #2 of the Certified Survey Map for Parcel #243. Both lots are to maintain the current private manhole at property address N255 Rapp Rd. and the existing "Y" lateral contained in said manhole, and for maintenance of the lateral after the "Y" to the main. It is further required that in the event of this parcel being separated that an easement is granted for the lateral from Lot #2 going through Lot #1. These stipulations will be made to the deeds associated with Lot #1 and Lot#2 with Columbia County before zoning permits can be issued. Motion carried unanimously.
- 5. **Election of President** Tatro opened nominations for president. Henry nominated Breunig, Tatro seconded. Motion carried unanimously.
- 6. Posting Locations- Website, Office, and Posting Box at the Little School House in Okee.
- 7. **Superintendent Report –** Brodeur reported the tree at the Red Cedar Lift Station was taken down.
